Applications are invited from suitably qualified candidates for the following positions:

(1) Stores Superintendent (on contract for one year) (Ref: SS/019) (2)Technical Assistant (Air Monitoring) (TA/AM/019) (3)Turner/Machinist (T/M/019)

Post 1: Stores Superintendent (on contract for one year) (Ref: SS/019)

Qualifications: Candidates should:

- A. possess a Diploma in Purchasing and Supply Management from a recognised institution <u>or</u> possess an equivalent qualification acceptable to the Board; and
- B. reckon at least eight years' experience in Procurement and Supply duties.
- Candidates should produce written evidence of experience claimed.

Salary Scale: Negotiable but not less than Rs 34,000.

Main Duties:

The Stores Superintendent will be responsible to the Chief Executive Officer for the proper planning, co-ordination and safe running of the stores section and cost effective purchase functions. He/ She will also be required to ensure the timely purchase of materials and that they are properly stacked and referred, putting in place safety measures to prevent loss.

Post 2: Technical Assistant (Air Monitoring) (TA/AM/019)

Qualifications:

Candidates should:

- (i) possess a Cambridge Higher School Certificate with passes at Principal Level in at least two subjects including Biology or Chemistry or Physics obtained on one certificate or Passes in at least two subjects including Biology or Chemistry or Physics at the General Certificate of Education 'Advanced level' or an equivalent qualification acceptable to the Board
- (ii) have a certificate in electronics or electrical or mechanical for troubleshooting and repairs of electronic and analytical instruments.
- (iii) have good communication and interpersonal skills.

<u> Main Duties:</u>

The Technical Assistant (Air Monitoring) will, *inter alia*, assist in the smooth operation of the Air Quality Monitoring System and carry out tests on site. He will be required to climb stacks up to a height of around 50 metres while monitoring quality of air emission.

Post 3: Turner/Machinist (T/M/019)

Qualifications:

Candidates should possess:

- (i) the Certificate of Primary Education;
- (ii) the National Trade Certificate Level 3 in the relevant trade awarded by the Mauritius Institute of Training and Development or an equivalent qualification from a recognised institution acceptable to the Board; and
